# **Bid Evaluation and Award**

An award will be made all or none to a sole responsible bidder whose bid is the lowest and meets the requirements set forth in the RFB. The lowest bidder will be the bidder offering the lowest total price.

# **Product Acceptability**

Unless specifically called for in the RFB, all products for purchase must be new, never previously used, and carry the manufacturers' standard warranty. Remanufactured, demonstrator, used or irregular items will not be considered.

Include literature (specification information) detailing each item offered. Any item bid which lacks sufficient descriptive literature or technical information to enable complete comparative analysis, may be disqualified.

# **Contract Period**

The College intends to award a contract to a sole bidder and establish a 12-month contract with the option to automatically renew for a second and third 12-month period. Price adjustments may be considered during any contract renewal period.
